The secretary read the Certificates of Election and administered the Oath of Office to the following six school directors (all At Large); Dennis Bugey, two-year term; Gerald Bertig, Joy Sasala, Ethan Sorbin, Timothy Taddie and Michael Yurky, four-year terms.

Mr. Bugey nominated Timothy Taddie as temporary president. As there were no other nominations, Mr. Bertig moved to close the nominations. Voice vote; unanimous. Timothy Taddie presided as temporary president.

Mr. Bugey nominated Vicki Smith for school board president. As there were no other nominations, Mr. McLoughlin moved to close the nominations were closed. Poll vote; with Mrs. Smith abstaining, on a 8-0-1 vote, Vicki Smith was reelected president of the Homer-Center School Board.

Mr. Taddie nominated Dennis Bugey for school board vice president. As there were no other nominations, Mrs. Sasala moved to close the nomination. Poll vote; with Mr. Bugey abstaining, on a 8-0-1 vote, Dennis Bugey was reelected vice president of the Homer-Center School Board.
